5 Reasons You Should Do a Track Day

Chances are pretty good that you have a racetrack within a couple of hours of where you live, and if you haven't taken the plunge and tried it, you're missing out. At a track day, you can spend a whole day with people who are out to Ride (with a capital "R").

Where else can you ride flat out for 30 minutes at a time without worrying about cops, oncoming traffic, or speed limits? It's less dangerous than riding on the street. There are no cars pulling out. There are no stoplights or intersections. And everyone is careful when they pass.

- 1) **Track stewards do their part to keep everyone safe.** Most riders at track days are intensely serious about safety, about holding a line, about the right gear and simply being safe. Unsafe riders are promptly kicked out of any track day.
- 2) **It's only as fast as you want it to be.** From beginner level to intermediate, expert to slicks-only, there are classes at every track day where you can slot in with riders who are at your level, or that you can learn from.
- 3) **Intermediate riders learn to explore their bikes' capabilities and learn how to ride faster, safer, and much more smoothly.** There is always an advanced rider in the pits who is willing to tow a beginner around the track and show you the lines and talk about technique.
- 4) **At most tracks you can rent the gear you will need,** such as tall boots, gauntlet gloves, and a high-quality suit or helmet for much less than you'd expect.
- 5) **Any bike is the right bike.** Go to most track days and you'll see guys on their Wide Glides leading supermotos, café racers, or sport bikes through the twisty bits.

Most racetracks have a club that will gladly let you go out and play for a day for a small fee, usually less than \$100. And there are some outfitters that will rent you the gear and the bike, as well as provide expert training if you want. Check out <https://www.sportbiketracktime.com/> and <https://www.n2td.org/>

It's not a race. You can't win a track day, and everyone knows that, so the riding is geared to be fun. It's going to be cheaper, safer, and much more fun than you ever imagined!

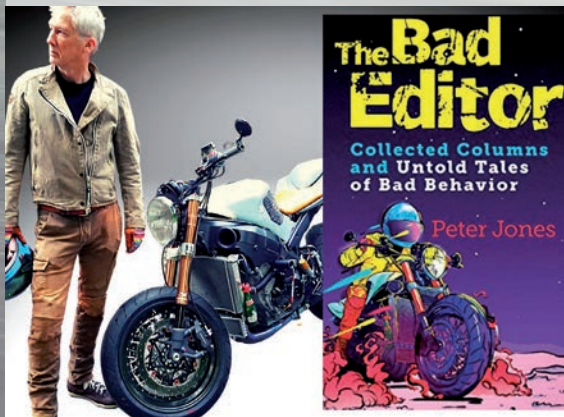


A MUST READ

Maverick Touring Seat



Being comfortable on your motorcycle, especially on long trips is a combination of bars, foot position, and most importantly, the seat. Christine Lepera knows this, and she and her team have created the ultimate touring seat in the Maverick. Many touring seats are so overdone and oversized that they make your bike look like a La-Z-Boy with wheels. But not the Maverick. It has a slim, beautiful design with exquisite diamond stitching. It creates an amazingly comfortable riding pocket for the rider and delivers some additional lower back support even without a backrest. The front tip of the seat has been tapered through the thigh area to allow for ease when stopping.

For taller riders, the Maverick also comes in a "Daddy Long Legs" edition that drops the seat height down and back almost 2 inches but keeps its comfort level. All in all, the Maverick delivers an excellent, stylish seat that is both comfortable and compliments your bike's style instead of overwhelming it.
